The Mayor then opened a public hearing, being the second public hearing, on the Reuse Plan for the Economic Development Revolving Loan Fund and the Housing Rehabilitation Revolving Loan Fund. Andrea Larson with Northeast Nebraska Economic Development District appeared before the Council stating that this hearing is being held to give the community an opportunity to be heard regarding the reuse plan for the Economic Development Revolving Loan Fund and the Housing Revolving Loan Fund. The re-purposing of these program income funds will be for the Water Main Improvement Project with any future program income to be applied to the project or returned to the Nebraska Department of Economic Development. Once all invoices are submitted to the DED, the close-out process will begin. There were no public comments.

The Park Board had applied for a Forestry Incentive Grant through the Lower Elkhorn Natural Resources District and Dennis Schultz with the LENRD was in attendance to present a check for \$2,096.75, which Dave Wimmer accepted on behalf of the Park Board.

The next agenda item was to discuss a new aquatic facility. David Wimmer, as a member of the Park Board and a member of the Pool Committee, spoke to the Council as to how we have arrived at this point. Kathy Mahannah, also a member of the Park Board and the Pool Committee, reported on the condition of the current pool which she stated is failing. The pool was built in 1986 and the pipes are rusting, the concrete is sinking and eroding, the filters have been patched prolonging their life, and the pool basin loses about 11,000 gallons daily which must be replaced. The City has contracted with Aquatic Design Consultants, Inc. and Advanced Consulting Engineering Services to work with the Pool Committee on facility programing, conceptual design and engineering services. Kevin McElyea of Aquatic Design Consultants appeared before the Council and showed a conceptual design for replacing the pool. This design would utilize the existing bath house, have zero entry, a separate area with play structures for young children, diving boards, dual slides, family waterslide and sunshades. The estimated costs of this facility is \$6.4 million. The City Administrator

stated it is the intent to pay for the new pool structure with an additional one-half percent sales tax, private funding and grants. The one-half percent sales tax could be backed by a general obligation bond to give the city a better interest rate. The additional sales tax and GO bond will need to be approved by the voters of the City. It was moved by Penrose and seconded by Smith to approve the project as presented. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried. The City will proceed with preparing the appropriate language for the ballot which the Council will need to approve before presenting it to the County Clerk/Election Official.

The City Administrator advised the Council that the Municipal Energy Agency of Nebraska (MEAN) is issuing a Request for Proposals on behalf of eleven MEAN participant communities for a solar PV installation project. In order to move forward, the City needs to appoint a MEAN representative to be the Special Engineer for this project who will handle the bid process. Once the bidding segment is complete, the project will then come before the Council to determine if the City wishes to participate in the project. Moved by Buse and seconded by Smith to approve the appointment of Matt Reed, a MEAN representative, as the Special Engineer for handling of the Request for Proposals, public opening and bid analysis for the solar project. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

David Branch, Executive Director of Cuming County Economic Development, appeared before the Council to give an update on the activities of his office. On the Owner-occupied Rehab Program with funds of \$491,000, 16 projects are being done in West Point for a total of \$150,000 which is income driven. On the Rural Workforce Housing Program, funding is being received from Nebraska Investment Finance Authority, Nebraska Department of Economic Development and local match, which will allow for the construction of duplexes in West Point and Bancroft and a triplex in Beemer. Once these buildings are sold, the money will go into a Revolving Fund for future projects.

The Council considered the new corporate manager application submitted to the Nebraska Liquor Control Commission by Casey's Retail Company, dba Casey's General Store 1181 naming Krystal Carter as manager. Moved by Smith and seconded by Penrose to approve this application and to notify the Nebraska Liquor Control Commission of such approval. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Swenson, seconded by Stokely, to approve the following applications for Special Designated Liquor Permits under the Nebraska Liquor Control Act:

- (a) GACC Booster Club for a Membership Dinner on August 20, 2021at the GACC Cafeteria.
- (b) Rush's Liquor Store for a fundraiser (Life Entertainment) for the West Point Community Theatre on September 17, 2021.
- (c) Rush's Liquor Store for the West Point Car Show for the West Point Community Theatre on September 19, 2021.
- (d) Native 32 Winery for a Farm to Fork Dinner on September 17, 2021 at the Nielsen Center.
- (e) Roadhouse Lounge for the West Point Car Show on September 19, 2021 at the Nielsen Center portico.

Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Buse, seconded by Swenson, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$8,634.11. Voting Yea: Stokely, Penrose, Swenson, Buse, and Smith. Nay: None. Abstaining: Hugo. Motion carried.

Stokely introduced a resolution to approve Change Order #1 and Payment No. 5 to Rutjens Construction for the West Point Water Main Improvement Project in the amount of \$29,968.10. Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

Swenson introduced a resolution to approve Payment No. 1 to Rutjens Construction for the Relocation of Utilities for the Highway 275 Improvement Project in the amount of \$73,962.00. Buse seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

The City Administrator reported to the Council on an inquiry by the Nebraska Auditor of Public Accounts regarding the use of the City's LB840 funds. Concern was raised on the following projects:

1) The street improvement project in the South Industrial area (2014) which helped develop that area and for Nebraska Vet Services – Embryo Harvesting Facility which created jobs and added to the City's valuation; 2) The south Hwy 275 paving project (2016) which was a joint venture with several businesses at the South Plaza and the Nebraska Department of Transportation; and 3) The Cuming County "Give, Get, Grow" program (2020). He stated the City needs to review its practices and ensure proper documentation. He has contacted the League of Nebraska Municipalities and the city attorney on this.

Moved by Swenson, seconded by Buse, to adjourn at 6:22 P.M. Voting Yea: Stokely,

Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.
